ENTRY INFORMATION AND DEADLINES

Schools are to use the MileSplit website to submit district entries. The deadline to submit district entries is noon on Tuesday, April 30, 2024.

ON-SITE INFORMATION

Coaches meeting will be held at 9:45 a.m. on the infield of the track.

Admission will be \$6.00 for everyone ages 6 and up. Fans can pay with cash at the admissions gate.

Bleacher seating is very limited at our facility. We would encourage spectators to bring lawn chairs and blankets for extra seating.

All athletes must be in uniform when entering through the pass gate. Coaches, managers, and administrators must be on the pass list you submit.

The top four places will medal and advance to Sectionals.

All throwing implements will be inspected and weighed at the shed starting at 9:00 a.m. The implements will be brought to the site by a meet official.

Coaches will sign in their pole vaulters' weights and poles at the scratch meeting.

Field event competitors are to report to the event site when called. Runners will report to the bullpen at the northeast corner of the track when called.

Warm-ups at the field events will not be allowed until the official worker is on site.

Shot put, discus, javelin, long jump, and triple jump competitors are given three attempts in the prelims and three attempts in the finals. Top 9 throwers advance to the finals.

The starting heights for the high jump and pole vault will be established by the games committee. These heights will be announced at the coaches' meeting. MSHSAA state rules will apply to warm-ups, passing heights, and breaking ties.

The facility is an 8-lane, all-weather track. Please have all athletes wear 1/4" spikes or less.

Starting blocks will be provided.

For exchange zones, "tennis ball" types of markers are allowed on the track. Chalk is allowed for the high jump. Chalk and/or markers have to be to the side of the runways. No tape is to be used on any area of the track surface.

Team camps and tents are to be set up in the grass field north of the track above the hill.

There will be a concession stand available.

Hospitality meal tickets will be given out at the coaches meeting for your coaches and bus driver.

T-shirts will be sold at the west end of the shed. Sizes and quantities are limited.

Buses can drop athletes off at the back of the school parking lot at the west end of the high school. Buses are then to circle back out of the school area and park at the softball field.
